




Questions from last meeting:


- If the PDX base is growing why are PDX FA not seeing the increase in flying.

- Uber codes given at 25 min per sideletter couple instances of FA reporting








- Lack of variety in overnights
- Fewer block legs, no mid-cons
- Day trips better
- No flexibility to drop
- AM to PM swaps

GEG - Shannon

- *Seems to be more true AM's/Pm's and that makes people happy. Is this due to reduced flying or have we mastered this?
- *is PAE's credit average 1 or more credit higher due to the % of day trips?
- *why can't circadian swaps, 4 days not be built into two-two days?
- *there is an uptick in plane changes, with that... Last day trip mid-day of BOI/GEG-have 2 plus hr sit, inbound is to LAND 40 mins or less for our outbound. This also just happened in PDX, why are we setting ourselves up for delays? FRIDAY
