# February Bid 342 - Scheduling Notes

Hello all and good day!

February trips are complete and are getting ready to be loaded into PBS before bidding opens. There is one major market change over February 9-11. Mid-con flights to ICT, OKC & AUS have moved earlier in the day, which means you'll see more of them built into a multi-day pairings instead of a stand-alone day trip. We have added new routes to LAX-SLC, SFO-AUS, SJC-AUS. State of Alaska trips have been adjusted thanks to your feedback. You will see a maximum of 4 legs per day, and the DLG-AKN triangle will no longer follow your first leg up to ANC.

New contract language goes into effect for this build: scheduled duty days cannot exceed 12 hours. You can be "rescheduled" up to 14 hours. With your approval, you may be rescheduled to maximum of 16 hours, only to accommodate a DH. More details may be found in Article 5, sections A & B. We were able to use both duty-rest rules for both aircraft types. This ensures that your scheduled duty day isn't longer than the preceding or following layover. Sit times have been reduced as much as possible, although you will see longer sits in PDX and SEA. After-midnight releases have been reduced on the Q400.
