

**September 2, 2022**

This communication is intended for Boise based Flight Attendant's and Flight Attendants who park at the Boise airport.

AFA Horizon - Local 16 Officers wanted to update you regarding the changes to employee parking in Boise.

Horizon was instructed, by the Port, to vacate the current parking area due to construction. The Elder lot was selected in the interim. Horizon Senior Leadership requested employees be allowed to park in lot 20, that request was denied by the Boise port. Inflight management, IBT and AFA leadership walked the Elder lot on 8/30/2022.

Your AFA Horizon – Local 16 Officers worked with the Boise Police Department to obtain information and the crime statistics of the surrounding area within a four-block radius. The data that was pulled was from 1/1 - 8/19, 2022. This information was forwarded to Inflight management to review. Below is the police data in its entirety for your review. Please be vigilant and aware of your surroundings.

There is only one report that occurred on that parking lot, DR#209576 (catalytic converter stolen from vehicle).

These are the main concerns your AFA Horizon – Local 16 Officers have, and these concerns have been provided to Inflight management:

- Lack of lighting
- Lack of cameras/surveillance
- Lack of fencing/security boundary
- Lack of on property security
- Uncontrolled access
- No "blue phone" for security assistance
- Shared shelter space with the public (*shelter is a public bus stop*)
- Crime statistics reports a catalytic converter theft from the Elder lot
- Overflow parking lot is darker and has the same safety concerns

Please file a Safety Report/FAIR to report irregularities and/or safety events. Dial 911 in an emergency. Put your health, safety, and security as priority. We must own our own safety.

If you have concerns with employee parking, please direct your concerns to Horizon Senior leadership; please cc your AFA Horizon – Local 16 Officers.
